CALL FOR PROPOSALS FROM NPOS TO DELIVER INTEGRATED COMMUNITY BASED HEALTH AND WELLNESS SERVICES FOR A 3-YEAR CYCLE 2023/24 - 2025/26

The Western Cape Government (WCG) Health Department aims to strengthen its collaboration with non-profit organisations (NPOs) through the creation of formalised partnerships for the community-based health service delivery across the primary health care settings. Partnerships are continued annually and are based on performance-based annual evaluations.

NPOs are invited to submit a business proposal if they are prepared to deliver any of the following services:

- 1) Integrated health and wellness services in the community are an array of interventions that support the actions people take to maintain health and well-being; prevent illness and manage disabilities; care for minor health problems and long-term conditions; and recover from periods of acute illness, injuries, hospitalisation and end-of-life care
- 2) Transitional care (including palliative care), which facilitates optimal recovery from an acute illness or complications of a long-term condition enabling the user to regain and maintain skills and abilities in daily living, with the ultimate discharge destination being home or an alternative supported living environment.
- 3) Community-based mental health services including group homes, licensed homes, day-care (including psychosocial support)
- 4) **Nutrition projects** including community-based nutrition rehabilitation and breastfeeding peer education at community level or within public health facilities.
- 5) **High Transmission Area Projects work** with 'key populations' at district level that are most likely to be affected by HIV and/or TB are identified as young women between 15 and 24 years, mobile men and migrant populations, sex workers and their clients, people who abuse alcohol and illegal substances, incarcerated persons, men who have sex with men and LGBTQIA+ individuals.

The Department of Health reserves the right to set programme-specific targets, in accordance with its Annual Performance Plans for 2023/24 -2025/26

NPOs working within identified sub-district boundaries should sign a transfer payment agreement with the relevant substructure in the City of Cape Town District or districts within the rural health services. NPOs are hereby invited to submit proposals for the delivery of community-based health services for the 3-year cycle. NPOs are kindly requested to submit their proposals to the relevant substructures in the City of Cape Town District or districts in the Rural Health Services. NPOs are encouraged to, where possible, work within the identified substructure/ district boundaries indicated below with respective contact details.
