In discussion it was noted that:

 The proposal coincided with potential landscape features such as historic water channels as indicated on the surveys provided.

DECISION

The Committee resolved to refer the matter to APM for approval. The Committee has no built environment concerns; and requires that prior to commencement of work an historical archaeologist identify areas of particular sensitivity. Thereafter, work on those areas must only be undertaken in the presence of that archaeologist.

Otherwise the site should be monitored by an Archaeologist, and a monitoring brief should be submitted to Heritage Western Cape for approval.

- Given the archaeological sensitivity, any below ground disturbance requires a section 35 application to SAHRA.
- The CPOA supported the current proposal.
- The building is in a grade I context but is not declared as a PHS.

DECISION

The Committee decided the grading of the buildings to be Grade II.

The Committee endorses the report prepared by Mr Rennie Scurr Adendorff (RSA).

The Committee approves the proposals as per the plans, elevations, detailing and specifications attached to the RSA report. It is recommended that the two flights of internal stairs proposed to the wine cellar be reconsidered and/or further motivated.

The following working drawing details are to be submitted to HWC for final approval prior to being implemented on site as per points (i-iv) of page 40 of the RSA Report:

- (i) Main house: final detail of new staircase to the attic bedrooms.
- (ii) Old wine cellar: detail of the stoep extension and addition of central steps.
- (iii) Old wine cellar: joinery details in af-dak portion on north side.
- (iv) Old wine cellar: internal two half flight staircases and openings.

Detailed landscape proposals are to be submitted for approval.

Approval is subject to the conservation architect's continued appointment and the submission of a completion report. RSA must monitor the work until project

completion and provide HWC with interim reports (including further details, specs and photo record).

- That an assessment of the work undertaken on other parts of the structure be undertaken by the said architect and submitted to HWC for consideration.
- A completion report be submitted by the architect assessing the work and impacts of unauthorised work on significance of the site.
- The applicant submits written undertaking to adhere to the above.

During the closed session it was noted that:

- Remedial work approved will be in terms of a compulsory repair order.
- The ExCo of HWC has resolved to reserve its right to bring charges in this matter pending assessment of the finalised project.
