In extent: 95, 7312 (Ninety-Five comma Seven Three One Two) hectares;

2. Erf 65275 Kenilworth, situated in the City of Cape Town Municipality, Division of Cape, Province of the Western Cape;
In extent: 2, 5696 (Two comma Five Six Nine Six) hectares;

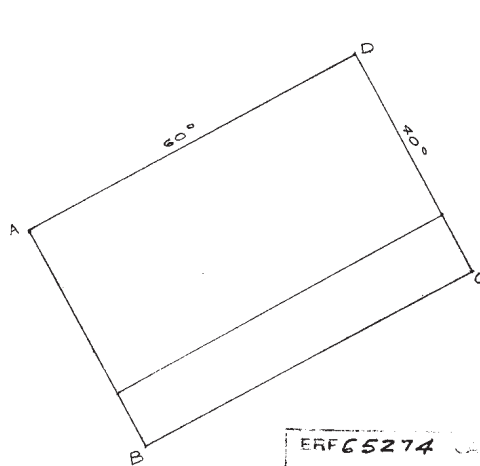

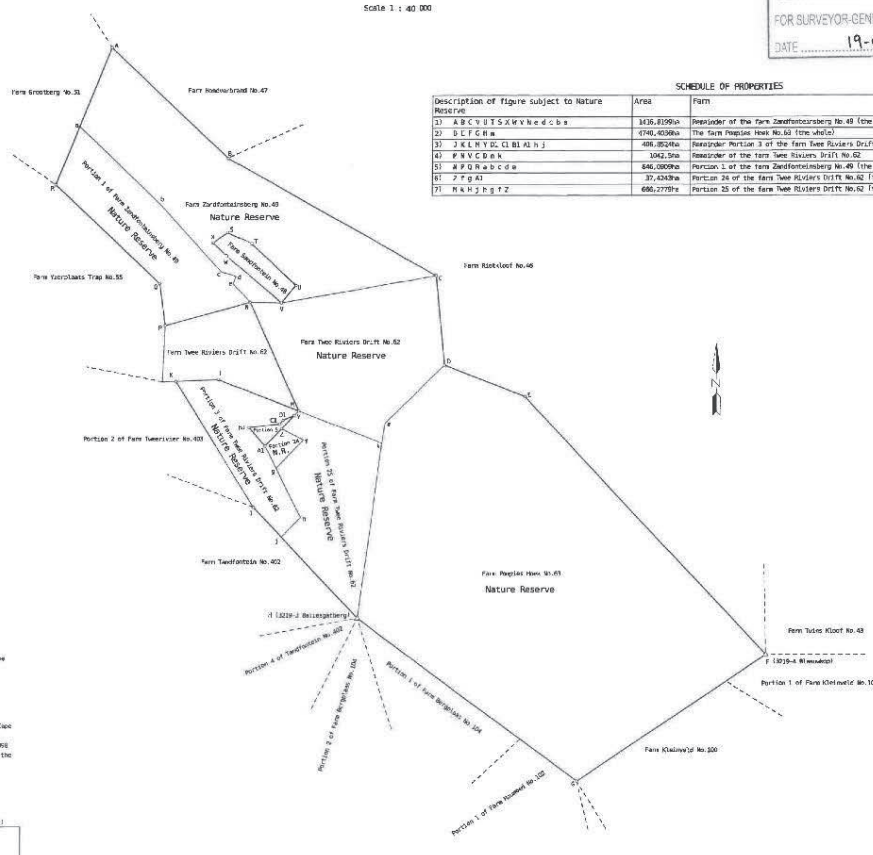
