# RE: LOCAL GOVERNMENT SUPPLY CHAIN MANAGEMENT FORUM MEETING 15 FEBRUARY 2013: NEKKIES CONFERENCE - WORCESTER

#### 1. Purpose

- 1.1. To inform municipalities of the next Local Government Supply Chain Management Forum meeting that is scheduled to take place on Friday, 15 February 2013.
- 1.2. To request all municipalities to submit one (1) name of a representative, preferably the SCM Manager or CFO, who will attend the Supply Chain Management Forum.
- 1.3. Where the senior official is unable to attend the forum meeting, the Municipality may nominate a representative, preferably an official of the Municipality's Supply Chain Management unit.

#### 2. Background

- 2.1 To date, the Supply Chain Management forums have taken place on a quarterly basis with the aim of providing additional support to municipalities in the implementation of the provisions of the Municipal Finance Management Act No. 56 of 2003 and other applicable legislations relating to Supply Chain Management.
- 2.2 The forum further seeks to be a co-operative endeavor between the Provincial Treasury and municipalities with the view to share experiences and best practices. The forum meetings have been a success and have been supported by all 30 municipalities within the Western Cape.

2.3 The Local Government Supply Chain Management (LGSCM) Directorate of the Provincial Treasury has scheduled the next SCM Forum meeting to take place on Friday, 15 February 2013, in Worcester at the Nekkies Conference Centre. The Supply Chain Management Forum meeting will commence at 09h00 ending at 13h00.

## 3. Agenda items to be discussed

- 3.1 The Provincial Treasury will afford the municipalities the opportunity to forward their proposed agenda items or issues to be addressed at the forum meeting.
- 3.2 Should a Municipality wish to forward any proposed agenda items for discussions, they can do so via email or fax no later than **1 February 2013**.
- 3.3 The agenda items includes but will not be limited to the following:
  - Presentation by the Experian Credit Bureau: To perform a clearance check on members/directors of companies to ascertain whether they are in service of the state.
  - Follow-up presentation by the SearchWorks Law Data Company: To perform a
    clearance check on members/directors of companies to ascertain whether they
    are in service of the state;
  - 3. **Presentation by National Department of Trade and Industry (DTI):** Presentation on the amended BBBEE Codes of Good Practice; and
  - 4. **Presentation by Construction Industry Development Board (CIDB):** Feedback on the non compliance of registering contracts on the I-Tender website.
  - 5. **Reporting on statistics** namely:
    - Awards above R100 000 and
    - Disposal and letting of immoveable property.
