RE: REPORTING FRAMEWORK OF AWARDS ABOVE R100 000

1. PURPOSE

- 1.1 To inform all municipalities with regards to the reporting of supply chain management contracts awarded above the value of R100 000 (VAT) included.
- 1.2 To request all municipalities to submit the monthly reporting of awards on contracts above R100 000 in a required template. (See Annexure A.)

2. BACKGROUND

2.1 Sections 74(1) and 104(1) (b) of the Municipal Finance Management Act (MFMA) prescribes the following regarding reporting obligations:

"The accounting officer of a municipality [and municipal entity] must submit to the National Treasury, the provincial treasury, the department for local government in the province or the auditor-general such information, returns, documents, explanations and motivations as may be prescribed or as may be required."

2.2 Municipalities are required to report on the awards of contracts above the value of R100 000. The purpose of these reports is to assist both the National and Provincial Treasury to monitor compliance on supply chain management reforms and to provide statistics on contracts awarded by local government. A contract should not be reported until it has been signed by all parties concerned. To this end municipalities should submit a separate report for each contract awarded above R100 000.

3. REQUEST

- 3.1 It is requested of municipalities to submit within 15 days of the end of each month reports on contracts above R100 000 to National and Provincial Treasury. Details of where reports must be submitted are as follows:


