COUNCILLOR REMUNERATION: RE-DETERMINATION OF UPPER LIMITS WITH EFFECT FROM 1 JULY 2008: GOVERNMENT NOTICE NO. R.1319 DATED 8 DECEMBER 2008

THE HEAD OF DEPARTMENT: LOCAL GOVERNMENT AND HOUSING

1. The National Minister for Provincial and Local Government, Mr. S. Shiceka, redetermined the upper limits of salaries, allowances and benefits of different members of municipal councils with effect from 1 July 2008. This upward adjustment is contained in Government Notice No. R.1319 dated 8 December 2008, and was published in Government Gazette No. 31687. In addition, the provincial Minister of Local Government, Environmental Affairs and Development Planning, Mr. P. Uys has in his letter 3/4/1/2 dated 10 December 2008 requested certain information from municipalities, which a mongst others, include information on budgetary provisions and affordability.

- 2. The current arrangement between the Department of Local Government and Housing and the Provincial Treasury regarding the assessment of increases in councilor remuneration is that the Provincial Treasury undertakes an affordability assessment and advise the Department of Local Government and Housing of the outcome accordingly. The affordability assessment includes amongst others, an assessment of the budget, the in-year monitoring and collections trends over a particular horizon. It has happened in the past that in certain cases the Provincial Treasury had to request additional information from municipalities to be able to draw logical conclusions and make informed decisions. In certain cases the requested information has not been readily available which impacted on the turn a round time of these assessments and subsequently the payment date of these allowances.
- 3. In an attempt to circumvent possible delays around the affordability assessments and subsequent approvals/mon-approvals, municipal managers (accounting officers) are required to complete the attached affordability verification certificate and return it to the Provincial Treasury by no later than Wednesday, 17 December 2008. It is important that the certificate be signed by the Municipal Manager.

- 5. The finalisation of the affordability assessments and subsequent approvals are dependen on your swift response.
