Organisation and staffing

For the financial year ending 31 March 2014:

- The number of posts filled was 1723
- 270 staff members were recruited
- 274 staff were employed in addition to the establishment

Programme 1: Administration

The underspending of R 1.9 million occurred mainly from delays in the filling of vacancies and capital infrastructure projects that were not concluded by the end of the financial year.


Programme 2: Social Welfare Services

The minimal unspent funds of R349 000 relates to the suspension of funding to non-compliant organisations and lower spending on placement of children fees.

Programme 3: Development and Research

The minimal unspent funds of R105 000 relates mainly to delays in the implementation of research projects and filling of vacancies.

Substance Abuse. Prevention and Rehabilitation

 Access to drug treatment and intervention services was expanded across. the Western Cape Province.

42 students graduated specialising in the treatment of substance abuse, as a result of partnerships between DSD and universities in the Western Cape.

Care and Services to Older Persons

• Funding was increased for residential care facilities for older persons, service

centres, independent- and assisted living facilities.

70 residential facilities for older people were registered in compliance with the Older Persons Act No. 13 of 2006.

Crime Prevention and Support

- The Provincial Quality Assurance Team for Diversion Accreditation was appointed by the National Minister.
- Probation officers received training on the Child Justice Act.
- A booklet with diversion programmes for practitioners and stakeholders. was developed.
- A Procedure Manual and an After-hour Assessment Policy document were drafted to regulate and standardise probation services.

Children and adults benefitted from social crime support services

Services to persons with disabilities

- A Disabilities Workgroup was established with the following objectives:
 - provide access to education
 - creating job opportunities
 - provide access to assistive devices
- The Premier of the Western Cape launched a pilot project on the identification of disabled children and youth at risk in Mfuleni and Vredenburg.

Child care and protection services

- The funding for Early Childhood Development (ECD) cost per child was increased from R12 to R15 per day in order to promote compliance with legislative requirements and to better remunerate ECD practitioners.
- 848 ECD practitioners in 425 facilities were capacitated to implement the ECD Programme, based on the National Early Learning Development Standards and other regulatory requirements.
- The programmes of 27 ECD organisations were registered in terms of the Children's Act enabling them to train practitioners in ECD facilities.
- During the 2013/14 financial year this programme:
- Finalised the policy guideline on Temporary Safe Care;
- Finalised the Provincial Child Protection Strategy;
- Developed and implemented a strategy to manage the foster care backlog in the Province; and
- Received approval from Provincial Cabinet on the ECD Strategy.

Victim Empowerment

- Services to victims of crime and violence have been improved by increasing the unit cost funding for shelters and developing norms and standards for facilities.
- A therapeutic programme for sentenced children displaying severe behaviour problems was implemented at our Child and Youth Care Centres.

Social Relief

- The Social Relief of Distress (SRD) programme, through its collaboration with South African Social Security Agency Western Cape, exceeded its annual household target for undue hardship relief.
- The set annual target was 1 640 households, the achieved number to date is 3 986 households. This improvement was made possible as a result of special projects focusing on malnourished children and through expansion of services.

Care and Support Services to families

- A Parenting Expo was held on 22 June 2014 and brought together beneficiaries and service providers in an effort to promote greater education and access to parenting services.
- Parenting Dialogues were held in the Metro South, West Coast and Eden Karoo regions to strengthen parenting networks and to identify parenting service needs with a particular focus on adolescents with parenting responsibilities.
- The Parenting in Africa Network was launched to strengthen the focus on parenting.
- The programme facilitated capacity building on the Integrated Parenting Framework and established parenting support groups that was attended by Non-Profit Organisation (NPO) and DSD officials.
- Fatherhood dialogues were held with beneficiaries and service providers in Cape Town and Oudtshoorn which focused on capacity building on the DSD Strategy on Fatherhood.

Youth Development

A youth development strategy was developed and approved.

The country's first Youth Café was launched in Rocklands, Mitchell's Plain.

An "UNCONFERENCING" event was attended by over 2 000 young people on 16 June 2013 to collect inputs from youth to inform the development of a youth strategy for the province.

Targeted feeding at Mass participation; Opportunity and access; Development

and growth (MOD) centres was continued.

Through the Expanded Public Works Programme (EPWP), 1 025 work opportunities were created for unemployed individuals.

Sustainable Livelihood

The number of Mass Opportunity Development after-school centres where the DSD provides nutrition support to youth were increased from 72 to 101, reaching 15 400 participants on any given day.

The targeted feeding programme was expanded to include households and

individuals faced with hunger and malnutrition.

Institutional Capacity Building and Support (ICB)

Training to NPOs regarding NPO registration requirements was provided in all Regions and Service Delivery Areas (SDAs) to ensure uniformity and enhance quality of service.

Regional, Provincial and National Dialogues were held which created a space for Civil Society Organisations and Government to collectively address service delivery needs in our communities.
