# THE ECONOMIC IMPACT OF HIV / AIDS IN THE WESTERN CAPE

HIV/AIDS in SA has become a health crisis of unprecedented proportions and it will impact severely on the economy of the country. One in five economically active individuals are likely to be affected throughout the country. Although the level of HIV prevalence is lower in the Western Cape than in other parts of the country, the rate of new infections is rising more rapidly.

## ALL INDUSTRIES WILL BE AFFECTED

The HIV/AIDS epidemic will impact on all areas of the economy and affect all businesses, irrespective of the size or the industry involved. Some industries are likely to be more seriously affected, but all businesses should take urgent action.

#### TAKE ACTION!!!


- 1. Develop a workplace policy and programme (speak to the Departments of Economic Affairs and Health, or see the workplace policy website).
- Implement a comprehensive awareness campaign (Speak to NACOSA).
- 3. Consider legal issues refer to the Labour Relations Act and the Employment Equity Act.
- 4. Implement training and counselling programmes (Contact NACOSA and the ATICC).
- 5. Ensure co-operation between owners / managers and workers / staff in all of the above.
- 6. Strengthen partnerships with Unions, government and NGO's for programme development & implementation.
