ACT

To amend the Members of the Western Cape Provincial Parliament Code of Conduct Act, 2002; to make the Act applicable to Members of the Provincial Cabinet; and to provide for matters incidental thereto.

BE IT ENACTED by the the Provincial Parliament of the Province of Western Cape, as follows:—

Amendment of section 1 of Act 3 of 2002

1. Section 1 of the Members of the Western Cape Provincial Parliament Code of Conduct Act, 2002, is amended—

by the substitution of the definition of “member” of the following definition:
“member” means a member [elected to]of the Provincial Parliament [but excludes] and includes a Member of the Provincial Cabinet.

Short title and commencement

2. This Act shall be called the Members of the Western Cape Provincial Parliament 10 Code of Conduct Amendment Act, 2003, and shall come into operation on a date determined by the Speaker by proclamation in the *Provincial Gazette*.
