

Mandate

- To facilitate gender-specific training programmes for all government employees in order to ensure an environment conducive to the mainstreaming of gender equality into programmes, projects, policies and budgets of all provincial line function departments.
- To monitor, evaluate, and report on the inclusion and integration of gender considerations into the business of Provincial Government.
